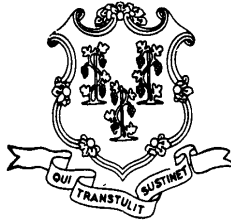

Reinstatement Instructions for Broker Licenses - Expired March 31, 2017

- A real estate broker license may be reinstated provided a completed reinstatement form and all applicable fees are submitted **not later than two years after the date of expiration of the license.**
- Reinstatement of a broker's license will only be accepted if all applicable fees are paid to bring the license to the current year and required continuing education is complete. Any such reinstated license shall expire on the next succeeding March 31st.

Reinstatement Fees:

- A total reinstatement fee of **\$412.50** must accompany the completed reinstatement application. Checks or money orders should be made payable to "Treasurer, State of Connecticut."

Reciprocal Licensees:

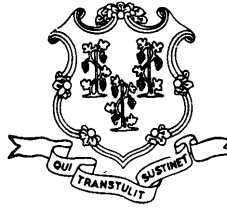
- Reciprocal licensees must include a copy of their current license from the reciprocal licensing authority.
