Subject: Exclusive Service Area Modification Request

Dear Mr. Cansler,

As part of the Eastern Connecticut Water Utility Coordinating Committee (WUCC) plan preparation, declaration of new exclusive service areas (ESAs) and maintenance of, or modifications to, existing ESAs are being evaluated.

The ESAs currently held by Montville Water Supply and the Southeastern Connecticut Water Authority (SCWA) and Norwich Public Utilities (NPU) within the Town of Montville were originally declared as part of the Southeastern CT WUCC plan dated March 2001. These ESAs were developed based on a combination of areas being served at that time by a public utility or town (known as existing service areas) expandable to unserved areas that were anticipated to be served by that public utility or town (exclusive service area). Unfortunately, the mapping quality at that time was not what it is today and some existing service areas were presented incorrectly. As a result, NPU would like to work with the SCWA to revise the designated ESAs in the area of our Stony Brook reservoir, water treatment plant, and Leffingwell Road so it accurately reflects areas the alignment of our main and property owned by NPU at the reservoir. This request also includes a revision to the location of the transmission main from the Stony Brook plant into Norwich along Leffingwell Avenue and Noble Hill Road which is being considered. While there are properties within Montville that will abut this new main, NPU does not intend to solicit customers within those areas.

Attached are maps showing the current SCWA and Norwich ESAs and the requested modification to the Norwich and SCWA ESAs. If you concur with the requested clarifications and modification, we can submit this revision to the Eastern WUCC for their acceptance.

I am available to discuss this in person with you or the Authority. Thank you for considering this request.


Dear Mr. Decker,

This letter is in response to your October 30, 2017 letter requesting a modification to the Southeastern Connecticut Water Authority (SCWA) Exclusive Service Area (ESA) in Montville, CT. Your letter requested modification of the Norwich ESA to include the Norwich facilities in Montville that are currently in the SCWA ESA, specifically the area around your Stony Brook reservoir, water treatment plant, and your transmission main along Leffingwell Road. Your letter included two maps showing the proposed new ESA realignment (attached).

The SCWA Authority met in November and approved a motion to authorize your requested ESA modifications, as shown on the attached maps, with the understanding that Norwich Public Utilities does not intend to solicit new customers within the new ESA boundaries.


Please let me know if you need any further information, or action, on the part of SCWA regarding this matter.
