

Opportunity for Public Comment

Re: Proposed Exclusive Service Area Modification between Southeastern Connecticut Water Authority and Norwich Public Utilities in Montville, Connecticut

Mr. McDaniel:

The Eastern Region Water Utility Coordinating Committee (WUCC) is in receipt of a requested modification of the Exclusive Service Area (ESA) boundary for public water service between the Southeastern Connecticut Water Authority (SCWA) and Norwich Public Utilities. The proposed ESA boundary would reassign parcels in the area of Leffingwell Road and Stony Brook Reservoir in Montville, currently served by Norwich Public Utilities, from SCWA ESA to Norwich Public Utilities' ESA. Please see the attached letters and mapping from Norwich Public Utilities and SCWA which indicate the agreement of the ESA holders to the proposed modification.


Pursuant to the Eastern WUCC Work Plan¹, please be advised that a 30-day opportunity for public comment on the proposed ESA boundary modification will run between January 18, 2018 and February 17, 2018. Notification of the opportunity for public comment will also be posted on the Eastern WUCC webpage¹. The Eastern WUCC will also accept public comments on this modification at its regularly scheduled meeting on February 14, 2018 at 1 PM at the Southeastern Connecticut Council of Governments offices, 5 Connecticut Avenue, Norwich, Connecticut. Any submitted comments should be directed via electronic mail to the Eastern WUCC Officers listed above, or via mail to address listed at the bottom of the page.

Following the public comment period, the ESA holders will be given the opportunity to respond to any comment received at the February meeting of the Eastern WUCC.
